If the nominations submitted by the Nominating Committee are the only nominations, then at the May meeting, the Board of Directors shall declare the slate of officers and directors so elected.

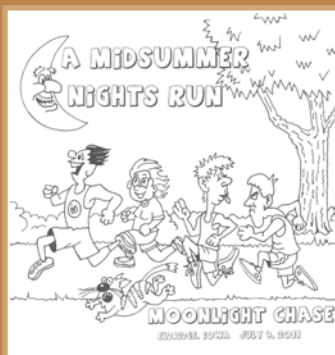
